ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370) AS APPLIED BY SECTION 26 OF THE WATER POLLUTION CONTROL (SEWERAGE) REGULATION (Chapter 358AL)

Scheme annexed to Plan No. CE19/GZ/003 describing

Sewerage Works under PWP Item No. B807CL Site Formation and Infrastructure Works for Public Housing Developments at Cheung Muk Tau

General Description of the Works

The Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. CE19/GZ/003 ("the Plan") annexed hereto and described hereunder. The proposed sewerage works are required to provide necessary infrastructure to serve the public housing developments at Cheung Muk Tau.

- 2. The general nature of the proposed sewerage works is as follows:-
 - (i) construction of approximate 1100 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plan; and
 - (ii) ancillary works including temporary closure and reinstatement of existing carriageways, footpaths, cycle tracks, pedestrian crossings, amenity areas and central reserves/refuge islands.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 17 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to close temporarily the existing carriageways, footpaths, cycle tracks, pedestrian crossings, amenity areas and central reserves/refuge islands or parts thereof within the limit of works area as shown on the Plan. Temporary alternative accesses will be provided and temporary diversions will be carried out during the construction period as and where required. Further notice, setting out the manner in which such existing carriageways, footpaths, cycle tracks, pedestrian crossings, amenity areas and central reserves/refuge islands, or parts thereof are to be closed, will be issued under section 18 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 20 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to require alteration of the course or position of the existing utility service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, drainage pipes, sewage pipes, gas pipes and any other service apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and the repair of any road surface, will be issued under section 20 of the Roads (Works, Use and Compensation) Ordinance as

applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.
