

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

ROAD WORKS UNDER PWP ITEM NO. B820CL  
SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING  
DEVELOPMENT NEAR TAN KWAI TSUEN, YUEN LONG

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan Nos. 199086/B&V/GP/101 to 103 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of at-grade carriageways and elevated carriageways for two-lane two-way traffic, at-grade footpaths, elevated footpaths, roundabouts, central medians/traffic islands, amenity areas, pedestrian crossings, signal-controlled pedestrian crossings, run-ins/run-outs, lifts, lift tower with associated staircase and a public transport interchange;
- (ii) permanent closure and conversion of sections of the existing carriageways into footpath and central medians/traffic islands;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways and cycle track;
- (iv) permanent closure and conversion of sections of the existing cycle track into carriageway and footpath;
- (v) permanent closure and conversion of sections of the existing central medians/traffic islands into carriageways;
- (vi) temporary closure and reinstatement of sections of the existing carriageways;
- (vii) temporary closure and reconstruction of sections of the existing footpaths/tracks, central medians/traffic islands and cycle track; and
- (viii) ancillary works including site formation, landscaping, drainage, sewerage, water supply, street lighting and utility works, staircase, geotechnical works including construction of retaining walls/slopes and slope stabilization works, and installation of street furniture and traffic aids.

The Plans and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Housing an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 14th day of September 2021.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
