Site Formation and Infrastructure Works for Public Housing Developments

at Chung Nga Road and Area 9, Tai Po – Phase 2 (Road Works)

General Description of the Works

Under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (“the Ordinance”), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. TP10/GAZ/C/DSB-01 (“the Plan”) annexed hereto and described hereunder. The proposed road works are required to provide engineering infrastructure works necessary to serve the development at Chung Nga Road West.

2. The general nature of the proposed works is as follows-
 - (i) construction of a carriageway, footpath, track, traffic islands, and vehicular run-in / run-out;
 - (ii) permanent closure and conversion of sections of the existing footpaths into carriageway;
 - (iii) permanent closure and conversion of a section of the existing footpath into track;
 - (iv) permanent closure and demolition of sections of the existing carriageway and footpath;

- (v) temporary closure and reconstruction of sections of the existing carriageway and footpaths; and
- (vi) ancillary works including slope, drainage, sewerage, landscaping, water and utility works.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 17 of the Ordinance may be exercised to close permanently sections of the existing carriageway and footpaths; and temporarily sections of the existing carriageways, footpaths, amenity areas and traffic islands within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths, amenity areas and traffic islands are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, gas pipes and any other service apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
