

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

ROAD WORKS UNDER PWP ITEM NO. B875CL
SITE FORMATION AND INFRASTRUCTURE WORKS FOR
PUBLIC HOUSING DEVELOPMENT AT SHA PO, YUEN LONG

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 4110336/BIN/SP/GZ/001 to 4110336/BIN/SP/GZ/007 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of carriageways, footpaths, a cycle track, central medians/refuge islands, amenity areas, a covered footbridge, run-ins/run-outs, pedestrian crossings, staircases and a lift;
- (ii) permanent closure and conversion of sections of the existing carriageways into footpaths, central medians/refuge islands and an amenity area;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways, a cycle track, central medians/refuge islands, an amenity area and noise barriers;
- (iv) permanent closure and conversion of sections of the existing cycle tracks into carriageways, footpaths and a central median/refuge island;
- (v) permanent closure and conversion of sections of the existing central medians/refuge islands into carriageways;
- (vi) permanent closure and reconstruction of a section of the existing staircase;
- (vii) permanent closure and conversion of sections of the existing access roads into carriageways, footpaths, an amenity area and a noise barrier;
- (viii) temporary closure and reconstruction of sections of the existing carriageways, footpaths, cycle tracks and central medians/refuge islands;
- (ix) demolition of sections of the existing covered footbridge and staircase; and
- (x) ancillary works including slope stabilization, drainage, water, sewerage, landscaping, environmental mitigation, public lighting, utilities, traffic aids, street furniture and geotechnical works, as well as construction of retaining walls, slopes and noise barriers.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 26th day of September 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
