Foreshore and sea-bed affected

Approximately 8 710 square metres of foreshore and sea-bed situated in the southern part of West Kowloon Cultural District as delineated and shown edged red on a plan, numbered KM10533, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Works include modification of the existing seawall and construction of a landing facility with associated ancillary facilities.
