Amendments under section 7

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to further amend the works and the use ('the Works and the Use') originally shown on Plan No. KZ1029 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 471 published under section 8(2) of the Ordinance on 29 January 2016 and 5 February 2016. The Works and the Use were authorized under section 11(1) of the Ordinance and the notice of authorization was published in G.N. 2075 on 15 April 2016 and 22 April 2016.

The Works and the Use were amended by the First Amendment Plan No. KZ1029A ('the First Amendment Plan') and described in the first amendment scheme annexed thereto. The First Amendment Plan and first amendment scheme were referred to in G.N. 6327 published under section 8(2) of the Ordinance on 11 November 2016 and 18 November 2016. The Works and the Use as amended by the First Amendment Plan and described in the first amendment scheme annexed thereto were authorized under section 11(1) of the Ordinance and the notice of authorization was published in G.N. 650 on 10 February 2017 and 17 February 2017.

The proposed further amendments are shown on Second Amendment Plan No. KZ1029B ('the Second Amendment Plan') and described in the second amendment scheme annexed thereto, which the Second Amendment Plan and second amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed further amendments are as follows:—

- (i) Revision of the originally proposed limit of works area;
- (ii) addition of parts of covered footbridge as well as staircase/escalator structure and footbridge columns;
- (iii) deletion of parts of the originally proposed covered footbridge, covered staircases, covered escalators, as well as the originally proposed staircase/escalator structure and footbridge columns;
- (iv) deletion of parts of the originally proposed covered footbridge and replaced by proposed covered staircase and covered escalators;
- (v) deletion of parts of the originally proposed covered staircase and replaced by proposed covered escalators;
- (vi) deletion of the originally proposed permanent closure and conversion of a section of the existing footpath into staircase/escalator structure and replaced by temporary closure and reconstruction of a section of the existing footpath;
- (vii) deletion of the originally proposed permanent closure and conversion of sections of the existing footpaths into footbridge columns and replaced by temporary closure and reconstruction of sections of the existing footpaths;
- (viii) deletion of the originally proposed permanent closure and conversion of a section of the existing footpath into planter and replaced by temporary closure and reconstruction of a section of the existing footpath;
- (ix) deletion of the originally proposed demolition and conversion of a section of the existing planter into footpath and replaced by temporary demolition and reconstruction of a section of the existing planter;
- (x) deletion of parts of the originally proposed covered staircase and replaced by proposed covered footbridge;
- (xi) temporary closure of sections of the existing carriageways and footpaths within the limit of works area; and

- (xii) revision of the proposed ancillary works including civil and structural engineering, drainage, water, electrical and mechanical, and landscaping works.

The Second Amendment Plan and second amendment scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed further amendments in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 22nd day of January 2019.

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
