

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING
DEVELOPMENTS AT PIK WAN ROAD, YAU TONG
(ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Acting Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. B812CL-GZ01 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a pedestrian walkway system, comprising footpaths, footbridges, lifts and lift towers with associated staircases, to connect Pik Wan Road, Ko Chiu Road and Lei Yue Mun Road;
- (ii) construction of a pedestrian walkway system, comprising footpaths, a footbridge, lifts and a lift tower with associated staircase, to connect Ko Chiu Road and Lei Yue Mun Road;
- (iii) widening of Ko Chiu Path and a section of Ko Chiu Road near Lei Yue Mun Road Playground;
- (iv) road junction improvement works at the junctions of (a) Pik Wan Road and O King Road, (b) Pik Wan Road and Ko Chiu Road, and (c) Cha Kwo Ling Road and Ko Chiu Road;
- (v) construction of footbridges, lifts and lift towers with associated staircases;
- (vi) permanent closure and conversion of sections of the existing carriageways into footpaths, central reserves/refuge islands and pedestrian crossings;
- (vii) permanent closure and conversion of sections of the existing footpaths into carriageways and pedestrian crossings;
- (viii) permanent closure and conversion of sections of the existing temporary car parks into carriageways, footpaths, central reserves/refuge islands and pedestrian crossings;
- (ix) permanent closure and conversion of sections of the existing central reserves/refuge islands into carriageways and pedestrian crossings;
- (x) permanent closure and conversion of sections of the existing pedestrian crossings into carriageway, footpaths and central reserve/refuge island;
- (xi) permanent closure and demolition of sections of the existing temporary car parks;
- (xii) demolition and conversion of sections of the existing slopes into carriageways, footpaths, lifts, lift towers with associated staircases, central reserve/refuge island and run-in/run-out;
- (xiii) temporary closure and reconstruction of sections of the existing footpaths, central reserves/refuge islands and pedestrian crossings;
- (xiv) demolition of sections of the existing slope;
- (xv) temporary closure of sections of the existing carriageways, footpaths, pedestrian crossings and central reserves/refuge islands within the limit of works area; and
- (xvi) ancillary works including drainage, water, sewerage, utilities, geotechnical, slope stabilization, public lighting, landscaping and traffic signalling works, as well as construction of retaining walls.

The Plan and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 8th day of January 2019.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
