### **Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL)**

#### **Scheme annexed to Plans Nos. 261044/GZ/101 and 261044/GZ/102 describing PWP Item No. B810CL Site Formation and Infrastructure Works for Public Housing Developments at Long Bin, Yuen Long**

#### **General Description of the Works**

1. The Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plans Nos. 261044/GZ/101 and 261044/GZ/102 (the "Plans") annexed hereto and described hereunder. The proposed sewerage works are to serve the future developments in the area.
2. The general nature of the proposed sewerage works is as follows:-
  - (i) construction of a sewage pumping station, about 950 metres of gravity sewers and associated manholes, and about 205 metres of twin sewage rising mains within the limit of works area as shown on the Plans; and
  - (ii) ancillary works including temporary closure and reinstatement of affected carriageways, footpaths, cycle tracks and traffic islands.

#### **Roads to be Closed**

3. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 17 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to close temporarily or permanently the existing carriageways, footpaths, cycle tracks and traffic islands or parts thereof within the limit of works area as shown on the Plans. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and where required. Further notice, setting out the manner in which such existing carriageways, footpaths, cycle tracks and traffic islands or parts thereof are to be closed, will be issued under section 18 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.

#### **Apparatus whose Course or Position to be Altered**

4. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to require alteration of the course or position of the existing utility service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, watermains, drainage pipes, gas pipes and other service apparatus lying within the limit of the works area, and to require repairing of any road surface

thereby disturbed. Further notice, setting out the manner in which the course or position of such utility service apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.
