DEVELOPMENT OF LOK MA CHAU LOOP—  
MAIN WORKS PACKAGE 1

Notice is hereby given that under section 11(2)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Chief Executive in Council has authorized the works and the use as described in G.N. 3774 published on 14 June 2019 and 21 June 2019 with modifications described hereunder. The modifications include modification to limit of works area, as shown on Modification Plan No. 60588085/GAZ/102A ('the Modification Plan'); and modification to resumption/clearance limit, as shown on Modification Resumption Plan No. YLM10562 ('the Modification Resumption Plan'). The Modification Plan and the Modification Resumption Plan have been deposited in the Land Registry.

The modifications are as follows:—

- (i) revision of the proposed limit of works area; and
- (ii) revision of the resumption/clearance limit in relation to modification as described in (i) above, including reduction of the scale of clearance for government land.
