# ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370) (Notice under section 8(2))

## ROAD WORKS UNDER PWP ITEM NO. B780CL SITE FORMATION AND INFRASTRUCTURE WORKS FOR DEVELOPMENT AT WANG CHAU, YUEN LONG

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. HPD/HWC/GZ001 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a single two-lane carriageway with a connected underpass, footpaths, traffic islands, lay-bys, pedestrian crossing and vehicular ingresses and egresses;
- (ii) widening of a section of Fung Chi Road and improvement works of its junction with Long Ping Road;
- (iii) construction of a footbridge over Long Ping Road;
- (iv) permanent closure and conversion of sections of the existing carriageway into traffic islands;
- (v) permanent closure and conversion of sections of the existing footpaths into carriageway and lay-by;
- (vi) permanent closure and conversion of sections of the existing traffic islands into carriageway and pedestrian crossing;
- (vii) permanent closure and conversion of sections of the existing cycle tracks into carriageway, footpath, traffic island, pedestrian crossing, footbridge and amenity areas;
- (viii) permanent closure and conversion of sections of the existing amenity areas into carriageways, footpaths, traffic islands, pedestrian crossings, footbridge, lay-by and cycle track;
- (ix) temporary closure and reconstruction of sections of the existing traffic islands; and
- (x) ancillary works including site formation, geotechnical, landscaping, waterworks, drainage, sewerage, utilities diversion, lighting, electrical and mechanical works, and construction of retaining walls and slopes.
