

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 8(2))

PWP ITEM NOS. 7817CL AND 7827CL (PART)
ROAD WORKS UNDER YUEN LONG SOUTH DEVELOPMENT
STAGE 1 WORKS AND STAGE 2 WORKS, PHASE 1

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 60566218/GAZ/100—112 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of at-grade carriageways (Road L1A, Road L1B, Road L2, Road L3, Road D1, Road D2, slip road at the existing Shap Pat Heung Interchange, village road adjacent to Tin Lung Tsuen), at-grade carriageways across existing nullahs, elevated carriageways, underpasses, footpaths, pedestrian subway, cycle tracks, cycle track *cum* pedestrian subway, cycle parking places, run-ins/run-outs, pedestrian crossings, central reserves/refuge islands/traffic islands, amenity areas and verges;
- (ii) reconstruction of the existing Tong Yan San Tsuen Interchange including the associated at-grade and elevated carriageways and underpasses;
- (iii) widening of sections of Lam Hi Road, Lam Yu Road, Tai Kei Leng Road, Kung Um Road, Kiu Hing Road, Shap Pat Heung Road, Long Hon Road, Lam Tai East Road and Tai Tong Road;
- (iv) realignment and widening of Tong Tai Road;
- (v) realignment of sections of Sham Chung Road, Shan Ha Road and Lam Yu Road;
- (vi) reconstruction of sections of Kiu Hing Road and Wong Nai Tun Tsuen Road;
- (vii) modification of the junctions at (a) Shap Pat Heung Road and Kiu Hing Road/Kung Um Road, (b) Tai Tong Road and Tai Kei Leng Road and (c) Lam Hi Road and Lam Tai West Road/Lam Tai East Road;
- (viii) permanent closure and conversion of sections of the existing at-grade/elevated carriageways into footpaths, cycle tracks, cycle parking places, central reserves/refuge islands/traffic islands, amenity areas and verges;
- (ix) permanent closure and conversion of sections of the existing footpaths into at-grade carriageways, cycle tracks, cycle parking places, central reserves/refuge islands/traffic islands and amenity areas;
- (x) permanent closure and conversion of sections of the existing accesses into at-grade carriageways, footpaths, cycle tracks, cycle parking places, central reserves/refuge islands/traffic islands and amenity areas;
- (xi) permanent closure and conversion of sections of the existing cycle tracks into at-grade carriageways, footpaths and amenity areas;
- (xii) permanent closure and conversion of sections of the existing central reserves/refuge islands/traffic islands into at-grade carriageways;
- (xiii) permanent closure and conversion of sections of the existing amenity areas into at-grade carriageways and footpaths;
- (xiv) permanent closure and conversion of sections of the existing verges into at-grade carriageways, footpaths, cycle tracks, central reserves/refuge islands/traffic islands and amenity areas;
- (xv) demolition and conversion of sections of the existing slopes into at-grade carriageways, footpaths, cycle tracks, central reserves/refuge islands/traffic islands and amenity areas;
- (xvi) permanent closure and conversion of sections of the existing footbridges across existing nullahs into at-grade carriageways and footpaths;

- (xvii) permanent closure and demolition of sections of the existing at-grade/elevated carriageways, footpaths, accesses, cycle tracks, central reserve/refuge island/traffic island and verges;
- (xviii) permanent closure and demolition of the existing footbridges across existing nullah;
- (xix) temporary closure and reconstruction of sections of the existing at-grade/elevated carriageways, footpaths, cycle tracks, central reserves/refuge islands/traffic islands, amenity area and verges;
- (xx) temporary closure and reconstruction of existing footbridges across existing nullah;
- (xxi) temporary closure and reconstruction of the existing run-ins/run-outs; and
- (xxii) ancillary works including site formation, landscape, drainage, water, electrical and mechanical, street lighting and utilities works, construction/modification/demolition of retaining walls, slopes, noise barriers and nullahs, and installation of street furniture and traffic aids.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 25th day of May 2021.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
