Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. CDEKAT0012 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a landscaped elevated walkway with associated lifts and staircase;
- (ii) permanent closure and conversion of sections of the existing amenity area into footpaths, lifts, staircase structure and footbridge supports;
- (iii) temporary closure and reconstruction of a section of the existing amenity area;
- (iv) temporary closure of sections of the existing carriageways, footpaths and amenity areas within the limit of works area; and
- (v) ancillary works including site formation, drainage, water supplies, utilities, landscaping, and electrical and mechanical works.
