Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL)

Scheme annexed to Plan No. 5193437-GAZ-2001 describing PWP Item No. 7842CL Infrastructure Works for Developments at Kwun Tong Action Area

General Description of the Works

The Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No 5193437-GAZ-2001 ("the Plan") annexed hereto and described hereunder. The proposed sewerage works are required to facilitate the future developments at Kwun Tong Action Area.


2. The general nature of the proposed sewerage works is as follows:-
 - (i) construction of about 100 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plan; and
 - (ii) ancillary works including temporary closure and reinstatement of affected carriageways, footpaths, central medians/traffic islands and amenity areas.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 17 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to close temporarily sections of the existing carriageways, footpaths, central medians/traffic islands and amenity areas within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths, central medians/traffic islands and amenity areas are to be closed, will be issued under section 18 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 20 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation may be exercised to require alteration of the course or position of the existing services and utilities, such as electricity cables and ducts, telecommunication cables and ducts, water mains, drainage pipes, gas pipes and any other service apparatus lying within the limit of the works area and to require repair of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such services and utilities to be altered and the repair of any road surface, will be issued under section 20 of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation as and when required.
