### **ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (CHAPTER 370) AS APPLIED BY SECTION 26 OF THE WATER POLLUTION CONTROL (SEWERAGE) REGULATION (CHAPTER 358AL)**

**Scheme annexed to Plan No. 5208968-GAZ-2002**

### **describing PWP Item No. B850CL Site Formation and Infrastructure Works for Public Housing Development at Choi Shun Street, Sheung Shui (Sewerage Works)**

#### **General Description of the Works**

1. The Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. 5208968-GAZ-2002 ('the Plan') annexed hereto and described hereunder. The proposed sewerage works are to serve the proposed public housing development at Choi Shun Street, Sheung Shui.
2. The general nature of the proposed sewerage works is as follows:—
  - (i) construction of about 450 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plan;
  - (ii) permanent closure and demolition of about 300 metres of existing gravity sewers and associated manholes within the limit of works area as shown on the Plan; and
  - (iii) ancillary works including temporary closure and reinstatement of lay-bys, carriageways, footpaths, pedestrian crossings and traffic islands.

#### **Roads to be Closed**

3. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 17 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL) may be exercised to close temporarily the existing lay-bys, carriageways, footpaths, pedestrian crossings and traffic islands or parts thereof within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such existing lay-bys, carriageways, footpaths, pedestrian crossings and traffic islands or parts thereof are to be closed, will be issued under section 18 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL) as and when required.

#### **Apparatus whose Course or Position to be Altered**

4. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL) may be exercised to require alteration of the course or position of any gas, electricity, water or telecommunications service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water-mains, drains, sewers, gas pipes and any other service apparatus lying within the limit of the works area, and to require repairing of any road surface thereby

disturbed. Further notice, setting out the manner in which the course or position of such services and utilities is to be altered and the repair of any road surface, will be issued under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358AL) as and when required.
