## PWP ITEM NOS. B764CL AND B861CL SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING DEVELOPMENTS AT SAN HING ROAD AND HONG PO ROAD, TUEN MUN (ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 5208968-SHHP-GAZ-1000 to 5208968-SHHP-GAZ-1005 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of carriageways, footpaths, cycle tracks, central medians/refuge islands, amenity areas, public transport interchanges, lay-bys, a footbridge extension, run-ins/run-outs, pedestrian crossings, a staircase and lifts;
- (ii) permanent closure and conversion of sections of the existing carriageways into footpaths, a cycle track, central medians/refuge islands, amenity areas, a public transport interchange and a lay-by;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways, cycle tracks, central medians/refuge islands, amenity areas, a public transport interchange, lay-bys and a slope;
- (iv) permanent closure and conversion of sections of the existing cycle tracks into a carriageway, a footpath, an amenity area and a lay-by;
- (v) permanent closure and conversion of sections of the existing central medians/refuge islands into carriageways, footpaths and amenity areas;
- (vi) permanent closure and conversion of sections of the existing amenity areas into carriageways, footpaths, cycle tracks, a central median/refuge island, a lay-by and a slope;
- (vii) permanent closure and conversion of sections of the existing access roads into carriageways, footpaths, cycle tracks, central medians/refuge islands, amenity areas, slopes and a public transport interchange;
- (viii) permanent closure and demolition of sections of the existing carriageways and footpaths;
- (ix) temporary closure and reconstruction of sections of the existing carriageways, footpaths, cycle tracks, central medians/refuge islands and amenity areas;
- (x) temporary closure of a section of the existing footbridge for construction of a footbridge extension;
- (xi) demolition and conversion of sections of the existing noise barriers into a carriageway and footpaths;
- (xii) demolition of the existing lift; and
- (xiii) ancillary works including slope stabilization, geotechnical, drainage, sewerage, water supplies, utilities, lighting, landscaping, electrical and mechanical works, installation of street furniture, traffic aids, traffic control and surveillance system, as well as construction of noise barriers, retaining walls and slopes.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Any objection lodged on a ground relating to any compensation (whether monetary or non-monetary) or any financial or other assistance in connection with the works or the use is, to the extent that it is lodged on that ground, invalid and treated as not having been lodged for the purposes of section 11 of the Ordinance. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 26th day of March 2024.
