## PWP ITEM NO. 7332CL (PART) WEST KOWLOON RECLAMATION—MAIN WORKS (REMAINDER)— FOOTBRIDGE AT JUNCTION OF SHAM MONG ROAD AND YEN CHOW STREET WEST IN SHAM SHUI PO

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. SDO-Z0107 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a covered four-span footbridge with associated lifts, lift towers, covered staircases, covered escalators, footbridge abutments and footbridge columns at the junction of Sham Mong Road and Yen Chow Street West;
- (ii) construction of footpath;
- (iii) permanent closure and conversion of sections of the existing footpaths into lift towers, footbridge abutments, footbridge columns and planters;
- (iv) permanent closure and conversion of the existing pedestrian crossings into planters and central medians/traffic islands;
- (v) temporary closure and reconstruction of sections of the existing footpaths and central medians/traffic islands;
- (vi) demolition and conversion of sections of the existing planters into footpaths, footbridge abutment, hard paved area and footbridge column;
- (vii) temporary demolition and modification/reconstruction of sections of the existing noise barriers;
- (viii) temporary closure of sections of the existing carriageways, footpaths, central medians/ traffic islands and pedestrian crossings within the limit of works area; and
- (ix) ancillary works including drainage, water and landscaping works.

The Plan and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—
