STAGE 5 INFRASTRUCTURE WORKS

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Acting Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 60102100/GAZ/S5/1.1 and 60102100/GAZ/S5/1.2 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of Roads D1 (part), L7, L9 and L16 of approximately 1600 metres (m) long in total and associated footpaths;
- (ii) construction of footpaths of approximately 1 100 m long in total connecting the proposed associated footpaths in (i);
- (iii) construction of Slip Roads S14 and S15 of approximately 350 m long in total connecting the proposed Road D1 (part) and the existing flyovers K73 and K72 respectively;
- (iv) construction of a subway of approximately 150 m long across Prince Edward Road East and the proposed Road D1 (part);
- (v) construction of central medians/traffic islands and pedestrian crossings;
- (vi) permanent closure and conversion of sections of the existing carriageways into footpaths or central medians/traffic islands;
- (vii) permanent closure and conversion of sections of the existing footpath into at grade carriageways;
- (viii) permanent closure and conversion of sections of the existing central medians/traffic islands into at grade carriageways or footpaths;
- (ix) permanent closure and conversion of a section of the existing amenity area into footpath;
- (x) permanent closure and demolition of sections of the existing carriageway, footpath, central medians/traffic islands and subway;
- (xi) temporary closure and reconstruction of sections of the existing carriageways, footpath, central medians/traffic islands and pedestrian crossing; and
- (xii) ancillary works including construction of lifts, staircases and vehicular run-ins; as well as drainage, water, utility and landscaping works.
