ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 7417RO-1B
IMPROVEMENT WORKS AT TAI O, PHASE 2 STAGE 2

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan Nos. GAZ/0001 to GAZ/0004 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a footbridge (also serving as an emergency vehicular access) connecting Kat Hing Back Street and Sun Ki Street;
- (ii) construction of a footbridge (also serving as an emergency vehicular access) connecting Lung Shing Street and Sun Ki Street;
- (iii) construction of a public car park to the north of Tin Lee Court;
- (iv) construction of an open place to the northwest of Tin Lee Court;
- (v) permanent closure and conversion of sections of the existing carriageways into footpaths, open place, on-street parking space and pedestrian crossing;
- (vi) permanent closure and conversion of sections of the existing footpaths into open place, run-ins/run-outs, public car park and pedestrian crossing;
- (vii) permanent closure and conversion of sections of the existing on-street parking spaces into carriageways, footpaths, open place, on-street loading/unloading space and pedestrian crossing;
- (viii) permanent closure and conversion of sections of the existing on-street loading/unloading spaces into footpath, on-street parking space and pedestrian crossing;
- (ix) permanent closure and conversion of the existing sitting-out area into open place;
- (x) permanent closure and conversion of sections of the existing amenity areas into footpath, open place, run-in/run-out, public car park and pedestrian crossing;
- (xi) permanent closure and conversion of sections of the existing slope into open place;
- (xii) temporary closure and reconstruction of sections of the existing footpaths, open place, on-street parking space and on-street loading/unloading space;
- (xiii) existing government foreshore and/or sea-bed to be affected by/reclaimed for the foundation works of the proposed footbridges in (i) & (ii); and
- (xiv) ancillary works including drainage, waterworks, slope works, street lighting, utilities, landscaping works, geotechnical works, electrical and mechanical works, construction of staircases and retaining wall, and installation of street furniture and traffic aids.

The Plans and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 16th day of November 2021.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
