Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by Section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, Subsidiary Legislation)

Scheme annexed to Plans Nos. 60336159/SGAZ/401 and 60336159/SGAZ/402 describing Sewerage Works under PWP Item No. 776CL (Part)

Site Formation and Infrastructure Works for Development at Kam Tin South, Yuen Long

General Description of the Works

- 1. The Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plans Nos. 60336159/SGAZ/401 and 60336159/SGAZ/402 (the "Plans") annexed hereto and described hereunder. The proposed sewerage works are to serve the future developments in the area.
- 2. The general nature of the proposed sewerage works is as follows:
 - (i) construction of about 1,380 metres of gravity sewers and associated manholes within the limit of works area to connect with the existing sewerage system at Kam Tai Road as shown on the Plans; and
 - (ii) ancillary works including reinstatement of existing carriageways, footpaths and verges.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Director of Environmental Protection proposes that powers under section 17 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, Subsidiary Legislation) may be exercised to close temporarily the existing carriageways, footpaths and verges or parts thereof within the limit of works

area as shown on the Plans. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths and verges or parts thereof are to be closed, will be issued under section 18 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, Subsidiary Legislation) as and when required.

Apparatus whose Course or Position to be Altered

For the purposes of or incidental to the works or the use, the Director of 4. Environmental Protection proposes that powers under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, Subsidiary Legislation) may be exercised to require alteration of the course or position of the existing utility services, such as electricity cables and ducts, telecommunication cables and ducts, water mains, stormwater drains, sewage pipes, gas pipes and any other service apparatus lying within the limit of the works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such services and utilities is to be altered and such road surface is to be repaired, will be issued under section 20 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) as applied by section 26 of the Water Pollution Control (Sewerage) Regulation (Chapter 358, Subsidiary Legislation) as and when required.
