TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under sections 17(1)(a) and 17(1)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the carriageways, footpaths, central medians/traffic islands, pedestrian crossings and landscaped deck structure integrated with noise barrier; and to reclaim the Government foreshore and/or sea-bed within the limit of works area as shown on Plans Nos. 60102100/D3_GAZ/101, 60102100/D3_GAZ/102 and 60102100/D3_GAZ/103 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 5062 published on 21 July 2017 and 28 July 2017. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 29 March 2019 to 28 March 2020, all public or private rights in, upon, under or over the sections of the carriageways, footpaths, central medians/traffic islands, pedestrian crossings and landscaped deck structure integrated with noise barrier to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period; and as from 29 March 2019, all public or private rights in, upon, under or over the Government foreshore and/or sea-bed to be reclaimed, shall be extinguished.

The works to be carried out in association with this closure mainly involve construction of Road D3 (Metro Park Section) including at grade carriageways with associated at grade footpaths, elevated carriageways with associated elevated footpaths, depressed carriageways and vehicular underpass; construction of Road L12d with associated at grade footpath; construction of at grade footpath, central medians/traffic islands, amenity areas and pedestrian crossings; construction of landscaped deck structure above Road D3; modification of Shing Kai Road (formerly named as Road D2), Muk Tai Street (formerly named as Road L6) and Road D3A, as well as other ancillary works.

The works to be carried out in association with this reclamation involve reclamation of the Government foreshore and/or sea-bed for construction of outfalls.
