## MODIFICATION WORKS OF MTR EMERGENCY ACCESS POINT 26 IN TUEN MUN

Notice is hereby given that the Secretary for Transport and Logistics proposes to execute the modification works of MTR Emergency Access Point (EAP) 26 in Tuen Mun as described in the scheme and shown on General Layout Plan No. 278463/EAP/GZ/G01; and Control of Building Plans and Commencement of Work Plan No. 278463/EAP/GZ/P01 (the 'Plans') annexed thereto. The scheme and the Plans have been deposited in the Land Registry.

The general nature and effects of the scheme are as follows:

The proposed works are required to modify MTR EAP 26 in Tuen Mun. The area of EAP 26 will be extended for reprovisioning of a part of the emergency vehicular access and assembly area which are necessary to be demolished for the roadworks of the Hung Shui Kiu /Ha Tsuen New Development Area. The proposed works include the followings:

- (a) construction of emergency vehicular access and assembly area at the proposed extension of EAP 26; and
- (b) ancillary works including associated civil engineering works, drainage works, waterworks, and electrical works.
