Safety cartridges and cartridges for small arms, not exceeding in the aggregate 20,000 rounds, or manufactured fireworks (pyrotechnics and life saving devices, such as marine distress signals), not exceeding in the aggregate 200kg, may be stored in a Mode B store.

4. 根據《2012 年危險品（適用及豁免）規例》（第 295E 章）第 7A 至 7D、8、8A 至 8F 條就 S1 危險品儲存豁免所列明之項目，並不需要上述牌照。

No storage licence is required for the storage of exemptions in respect of S1DG under sections 7A to 7D, 8, 8A to 8F of the Dangerous Goods (Application and Exemption) Regulation 2012 (Cap. 295E).
