**Construction Standard CS2:2012 – Steel Reinforcing Bars for
the Reinforcement in Concrete**

Purchaser's Tests – Grace Period for Bond Properties

As announced in my memo ref: CEDD T 4/1/3/21 dated 27 November 2013, CS2:2012 shall be referred as the required standard for steel reinforcing bars for reinforcement in concrete in all public works contracts for which the tenders are invited on or after 1 January 2015.

2. With regard to purchaser's tests, a grace period of two years is introduced for bond properties. Purchaser's test on bond properties needs not be undertaken for steel reinforcing bars delivered to site on or before 31 December 2016.
