# 我們的環保政策與工作

我們在建造工程的各個階段,均非常注重環境的保護,致 力履行綜合管理系統政策下所訂定的各項承擔,包括:

- 遵守與保護環境相關的法例及其他規定
- 創建安全、綠化及可持續發展的環境
- 監督顧問及承建商的表現,確保他們遵守本署的環 保規定
- 避免環境污染,並致力緩解因工程項目及部門運作 而可能對環境構成的影響
- 在可行的情況下,奉行以下原則:資源減省、資源
  再用和資源循環再造
- 為持續改進表現,定期檢討綜合管理系統的成效以 及其目標和指標

我們還推行了一套環境管理系統,並已取得 ISO14001 認 證。我們的環保措施和綠化成果,亦獲得專業團體的認 同。

# **Our Environmental Policy and Activities**

We place due emphasis on environmental protection considerations in all stages of our construction projects, which are achieved through the following commitments in our Integrated Management System (IMS) Policy:

- Complying with legal and other requirements relevant to environmental protection
- Creating a safe, green and sustainable environment
- Monitoring the performance of our consultants and contractors to ensure their compliance with our requirements on environmental protection
- Preventing pollution and mitigating potential environmental impacts arising from our projects and operations
- Observing the principles of reduction of consumption, reuse and recycling of resources wherever practicable
- Achieving continual improvement through regular review of the effectiveness of our IMS as well as its Objectives and Targets

We have also implemented an environmental management system and obtained ISO14001 Certification. Our environmental measures and greening achievements have been well recognized by professional bodies.



# 清新空氣約章

### 綠色辦公室

我們積極履行「清新空氣約章」的承諾。截至2019年, 土木工程拓展署大樓(總部大樓)連續第17年獲頒發室內 空氣質素良好級檢定證書,連同總部以外的辦事處,本署 獲頒合共13張「良好」級檢定證書。

我們繼續履行「減碳約章」的承諾。在2018年4月至2019 年3月期間,總部大樓的運作直接產生的二氧化碳為31.98 公噸,比上一年度多8.67公噸。通過用水用電間接排放量 則為2,332.09公噸,比上一年度多41.72公噸。二氧化碳的 總排放量比上一年多50.39公噸。二氧化碳排放量增加的 主要原因是總部大樓的員工數目和政府車輛耗油量增加 及在酷熱天氣下大樓的用電量增加。香港天文台記錄的 每月平均氣溫較上一年高。總部大樓的二氧化碳排放量 為每員工2.03公噸,比上一年度低0.01公噸。在同一期間, 工務中央試驗所的運作直接產生的二氧化碳則為18,508.92 公噸。

# **Clean air Charter**

### **Green Office**

We actively fulfilled our commitment under the "Clean Air Charter". Up to 2019, the Civil Engineering and Development (CED) Building has been awarded the "Good Class" Indoor Air Quality Certificate consecutively for 17 years. Together with our outstation offices, we were awarded a total of 13 "Good Class" Indoor Air Quality Certificates.

We continued to fulfill our obligations under the "Carbon Reduction Charter". From April 2018 to March 2019, the amount of carbon dioxide generated directly by the operation of the CED Building was about 31.98 tonnes which was 8.67 tonnes more than the preceding year. The amount emitted indirectly through water and electricity consumption was about 2,332.09 tonnes which was 41.72 tonnes more than the preceding year. The total amount of carbon dioxide emitted was 50.39 tonnes more than that of the same period of the preceding year. The increase in carbon dioxide emission was mainly due to the increase in staff number and petrol consumption by government vehicles of CED Building, and higher electricity consumption of CED Building under hot Higher monthly mean air temperatures were weather. recorded by the Hong Kong Observatory as compared with the preceding year. The carbon dioxide emission at CED Building per staff was 2.03 tonnes which had been decreased by 0.01 tonnes as compared with that in the preceding year. During the same period, the amount of carbon dioxide generated directly by the operation of the Public Works Central Laboratory was about 15.85 tonnes, while the amount emitted indirectly through water and electricity consumption was about 18,508.92 tonnes.

## 使用電動汽車

電動車由內置的可充電電池的電力推動。由於電動車輛 不會排放引致路邊空氣污染的廢氣及減少排放溫室氣 體,從而有助改善路邊空氣質素。此外,電動車行走時不 會進行內燃運動,因而較以內燃引擎推動的車輛寧靜,有 助减少交通噪音的污染。截至2019年12月,本署現有18輛 (13輛全電動車及5輛混能車)電動汽車。我們更多使用 電動汽車,藉此協助减少排放溫室氣體,改善路邊空氣質 素及減低交通噪音污染水平。

### **Use of Electric Vehicles**

Electric vehicles (EV) is driven solely by the electrical power using its built-in rechargeable batteries. As EV does not exhaust emission which is one of the major sources of roadside air pollution, it reduces greenhouse gas emissions and thus improves roadside air quality. Moreover, without internal combustion occurs in EVs in motion, they are quieter than those driven by internal combustion engine, and help reducing traffic noise pollution. As in December 2019, CEDD has 18 EVs (13 full EVs and 5 hybrid EVs) in service. By adopting more EVs, we have been contributing to reducing greenhouse gas emissions, improving roadside air quality and reducing traffic noise pollution.

# 節省用電

本署的總耗電量,由2013年的6,666,775度减少至2019年 的6,087,071度,减少了8.7%,並已達到減少用電量5%的 目標。

### **Saving in Electricity Consumption**

The total electricity consumption of the Department has been reduced by 8.7%, from 6.667 million kWh in 2013 to 6.087 million kWh in 2019, which has achieved the target of 5%.

# 土木工程拓展署環保報告 2019

## 節省用電措施

在2019年度,本署推行/計劃推行的節省用電措施如下:

- 日常運作 本署繼續積極提醒同事採取日常節能 措施(如在離開辦公室時關掉電燈及電腦)。
- (2) 節能方案 本署正提升本署大樓的通風系統以改 善其效能。本署亦繼續與機電工程署保持聯繫,探 討各種可行的節能方案。

### 環保表現

我們每年訂定環保目標和指標,務求在環保表現方面精 益求精。現將截至2019年的工作成效扼述如下:

## 環保指標

- 减少總用紙量,較2003年少22.5%
- 以環保紙取代普通紙至總用紙量的 60%
- 减少本署的總用電量,較2013年少5%
- 本年度美化150幅在「長遠防治山泥傾瀉計劃」下 鞏固的斜坡
- 本年度種植至少 79 萬棵樹/灌木

## 成績

- 總用紙量較 2003 年減少 29.3%
- 環保紙佔總用紙量的 61.7%
- 本署的總用電量較 2013 年減少 8.7%
- 本年度已美化 165 幅在「長遠防治山泥傾瀉計 劃」下鞏固的斜坡
- 本年度已種植 92 萬棵樹/灌木

### **Electricity Saving Measures**

In 2019, we have implemented the following electricity saving measures:

- (1) Housekeeping measures we have continued to proactively remind colleagues to adopt daily energy saving measures (e.g. switching off lighting and shutting down computers when away from office).
- (2) Electricity saving projects we are upgrading the ventilation system of CED Building to enhance its efficiency. We have kept liaising with the EMSD to explore feasible energy saving opportunities.

### **Environmental Performance**

To achieve continuous improvement in our environmental performance, we have set annual environmental objectives and targets. Below is a summary of our performance as in 2019:

### **Environmental Targets**

- Reduce total paper consumption by 22.5% as compared with that in 2003
- Substitute 60% of normal plain paper with recycled paper
- Reduce total electricity consumption of the Department by 5% as compared with that in 2013
- Landscape 150 upgraded slopes under the Landslip Prevention and Mitigation Programme in this year
- Plant at least 0.79 million trees/shrubs in this year

## Achievement

- Total paper consumption reduced by 29.3 when compared with that in 2003
- Recycled paper accounted for 61.7% of total paper consumption
- Electricity consumption of the Department reduced by 8.7% when compared with that in 2013
- 165 upgraded slopes under the Landslip Prevention and Mitigation Programme have been landscaped in this year
- 0.92 million trees/shrubs have been planted in this year
