Mine Blasting Certificate (MBC) Application

此表格供接受学徒训练以申请矿场燃爆证书的人士使用。根据香港法例第 295G 章《危险品(管制)规例》第 44 条,任何人不得致使或准许任何个人在任何地点使用任何分量的 S1 危险品;就在持牌爆破地盘使用的 S1 危险品而言,除非该名个人是根据香港法例第 285B 章《矿场(安全)规例》第 22 条发出或续期的矿场燃爆证书的持有人或是根据香港法例第 295G 章《危险品(管制)规例》第 45 条发出或续期的使用(个人)牌照的持牌人。

This form is intended for a person who wish to apply for Mine Blasting Certificate (MBC) by apprenticeship. Under section 44 of the Dangerous Goods (Control) Regulations (Cap. 295G), a person must not cause or permit any individual to use any quantity of S1DG at any location unless for S1DG used in a licensed blasting site, the individual is the holder of a mine blasting certificate (MBC) issued or renewed under regulation 22 of the Mines (Safety) Regulations (Cap. 285B), or is the licensee of a use (individual) licence and is permitted under the licence to use that quantity of S1DG issued or renewed under section 45 of the Dangerous Goods (Control) Regulation (Cap. 295G).
